5. **CONTEST DEADLINE: February 27, 2012. All special events must be turned in at this time. If entry for open events is postmarked after 2/27/12, include late entry fee of \$5.00 per event entered. Late entries must be received by March 2, 2012. Sorry, No Refunds.**
