General Information

- Entry deadline is Friday, April 11, 2025. Entries submitted after this date must include a \$25 late fee. No entries will be accepted after April 18, 2025. No refunds or credits will be given after the deadline.
- Contest starts promptly at 8:30am on Saturday and 8:00am on Sunday. Doors open one hour before start time.
- You may submit your entry online; however, you must print a copy and send it in with a money order/cashier's check or pay with PayPal online. Please print an extra copy for yourself.
- Age divisions for all individual events are: 0-6, 7-9, 10-12, 13-15 and 16-up.
- Special Beginner solo is offered for athletes who have never won a first place in solo.
- · No flash photography, eating, drinking, or smoking in the gym.
- Schedule is at the discretion of the contest director.
- A facility fee will be added to the individual entry to help cover facility costs.
- Official 2025 Miss Majorette T-Shirts with new design can be pre-ordered for \$20.

Class A- Open Contest

All events for the open contest will follow the order on the entry form as much as possible.

Awards: First place trophies. Second through fifth place awards. First through fifth place awards for all novice events

Miss Majorette of Florida Pageant

Advanced division only. Solo determines division. This pageant qualifies winners and royalty for the Miss Majorette of America Pageant at AYOP. Contestants will compete in Dress Modeling with interview (20% of overall placements), X- Strut (40%), and Solo (40%). **Awards:** First place overall winner will receive a trophy, banner, tiara, and flowers. Second through fifth place will receive a trophy. Awards will be given to the winners of each event.

Florida Beginner & Intermediate Pageant

Solo determines division. Contestants compete in Costume Modeling with interview (20% of overall placement), X-Strut (40%), and Solo (40%). **Awards**: First place overall winner will receive trophy, banner, tiara, and flowers. Second through fifth place will receive a trophy. Awards will be given to the winners of each event.

Florida Novice Pageant

This event is open to all novice twirlers. Contestants will compete in Costume Modeling with no interview (20% of overall placement), Basic (40%), and Solo (40%). **Awards**: First place overall winner will receive a special novice award, banner, and tiara. Second through fifth places will receive a special novice award.

Sunshine State Marching Queen

This event is open to all twirlers. If you are Advanced in either Basic or Military you must enter the Advanced division. Contestants will compete in Costume Modeling with no interview (20% of overall placement), Basic (40%), and Military (40%). **Awards:** First place overall winner will receive a trophy and banner. Second through fifth places will receive award.

Sunshine State All Around

This event is open to all twirlers. Solo determines division. Contestants compete in X-Strut, Solo, and 2-Baton. All events are counted equally. **Awards**: First place overall winner will receive a trophy and banner. Second through fifth places will receive award.

Rhythmic & High School & Collegiate Twirl

Twirlers will perform to their own music and should email their music to Lynette.Jankowski@gmail.com. Collegiate routines may use multiple batons. **Awards**: First through fifth place awards.

Show Twirl

Competitors will perform to their own music and should email their music to Lynette.Jankowski@gmail.com. Props and novelty batons are permitted. The time limit is 1:30-2:00. This event will be held during the team competition on Sunday. **Awards**: First through fifth place awards.
