Title Events

Sweetest Beignet (0-6, 7-9, 10-13, & 14+)

These athletes are novice to beginner, working on basic twirling skills, and are NOT completing more than a one spin.

<u>Dutchess of the Masquerade (0-9, 10-13, 14-17, & 18+)</u> These athletes are beginner to intermediate athletes. Completing 1 to 3 spins, single/double element tricks.

Queen of the Krewe (0-9, 10-13, 14-17 &18+,) These athletes are beginner, int, adv and are completing more than a two spin or three spin and single or double element trick.

Overall Winner in each group will be determined using place points: 1st place=1 point, 2nd place=2 points, etc. For example an athlete placing 1st in solo (1 point) 4th in modeling (4 points), and 2nd in 2-baton (2 points) would have a total of 1+4+2=7 points. The athlete with the fewest place points in each age division will be the winner. A tie in place points will be broken by combining total scores in all disciplines.

Sweetest Beignet will have four age categories 0 -6, 7-9, 10-13, & 14+. They must compete in modeling, basic strut, and presentation.

Dutchess of the Masquerade will have four age categories 0-9, 10-13, 14-17, & 18+. They must compete in Solo and Artistic Twirl.

*Music for the Lagniappe Champion will be Adv Solo music. You will not be deducted points for finishing early.

*The disciplines for the title events are separate from the "regular" individual disciplines. So, an entry in the title events enters an athlete in the required disciplines for their level and only athletes that entered in the title events will compete in each of those events. Athletes that entered in the title events may also choose to enter the same events in the Mardi Gras Masquerade Competition.
