### **Miss Warren County Twirler**

Contestant must live or attend school in Warren County.  
No division based on level age only.

### **Miss Maple Princess**

Encouraged for Primary or Novice twirlers. Contestants compete in modeling with interview, basic strut, and solo.

### **Miss Maple Queen**

Beginner, Intermediate, Advanced. Contestant competes in modeling (in costume) with interview, super X strut, and solo.

### **Dress Model**

Advanced division only. Open to all but considered an advanced division.

### **Best Appearing**

Model in costume in Circle-T formation, no interview.

### **My First Solo**

For first time twirlers! Do basic twirls for a minimum of 30 sec  
You may wear a costume, leotard, or shorts.

### **Solo**

Pri 0:30-2:00, Nov 0:30-2:00, Beg 1:30-2:00, Int 1:50- 2:00  
Adv 2:20-2:30

### **Show Twirl**

Show Twirling is interpretive, free-style twirling where contestants select own cd music and use any combination of twirling instruments in order to display their total show performance. Props and twirling equipment are limited to that which can be hand carried in one trip by contestant only. Electrical props are not permitted.

### **Rhythmic Twirl**

Open to advanced competitive twirlers only.

### **Photogenic**

Bring an unframed photo (no larger than 8 x 10) the day of the contest.
